

Adult Award -Volunteer of Excellence Nomination

Description

The Volunteer of Excellence award recognizes volunteers who have contributed outstanding service while partnering directly with girls in any pathway to implement the Girl Scout Leadership Experience (GSLE) through use of the National Program Portfolio or who have contributed outstanding service in support of the Council's mission delivery to girl and adult members.

Criteria

- The nominee is an active, registered adult Girl Scout.
- The nominee has completed all training required for their role(s)
- The nominee has performed beyond expectations for the position to deliver the GSLE to girls using the National Program Portfolio, **or**
- The nominee's performance has been beyond the expectations of the position and has supported the council's mission-delivery goals in one or more of the following areas: membership development/community cultivation, volunteer relations and support, program, leadership and governance, fund development or council support services
- The nominee actively recognizes, understands and practices the values of inclusive behavior.

Nomination

- Complete the nomination form on the next page
- Two [letters of endorsement](#) are to be submitted with the nomination form. Individuals or groups familiar with the service performed may submit letters of endorsement. The person making this nomination may not submit a letter of endorsement.
- The recognition committee reviews the nomination documentation, then approves or denies it.

Submit completed nomination form and 2 letters of endorsement in to the Council no later than **May 31.***

****Nomination packets must be complete. Partial submissions will not be eligible for consideration.***
