# **Description**

The Thanks Badge honors an individual whose ongoing commitment, leadership, and service have had an exceptional, measurable impact on meeting the mission delivery goals and priorities of the entire council or the entire Girl Scout Movement.

### Criteria

- · The nominee is an active, registered adult Girl Scout.
- The nominee has completed all training required for their role(s)
- The nominee has performed beyond expectations for the position to deliver the GSLE to girls using the National Program Portfolio, **or**
- The nominee's performance has been beyond the expectations of the position and has supported the Council's mission delivery goals in one or more of the following functional areas: Membership Development/Community Cultivation, Volunteer Relations and Support, Program, Leadership and Governance, Fund Development, and Council Support Service (such as IT, Customer Service, Merchandising, Marketing/Communications).
- The nominee actively recognizes, understands and practices the values of inclusive behavior.

# **Description**

The Thanks Badge II honors a previous Thanks Badge recipient who has continued to provide exemplary service in a leadership role, resulting in a measurable impact on meeting the mission delivery goals and priorities of the entire Council or the entire Girl Scout Movement.

### Criteria

- All criteria for Thanks Badge (above) AND
- · The nominee has previously received the Thanks Badge

## **Nomination Process**

- Complete the nomination form on the next page
- Four <u>letters of endorsement</u> are to be submitted with the nomination form. Individuals or groups familiar with the service performed may submit letters of endorsement. The person making this nomination <u>may not</u> submit a letter of endorsement.
- The recognition committee reviews the nomination documentation, then approves or denies it.
- The recognition committee sends notification of the decision to the Council's board of directors for confirmation.
- The nominator will receive notification of approval or denial of award within three weeks of submission deadline.

Submit completed nomination form and 4 letters of endorsement in to the Council no later than **May 31.**\*
\*Nomination packets must be complete. Partial submissions will not be eligible for consideration.
