

## HOLD HARMLESS, INSURANCE AND VIDEO/PHOTOGRAPHY AGREEMENT

The(	Organization/Individual) hereafter referred to
as lessee agrees to indemnify Girl Scouts of the Colonial Coast again	st and hold them free and harmless from any
cause and all claims, demands, loss, damage, etc., and other legal ex	penses arising out of the lessees' use of the
Girl Scout camp property.	

The lessee also agrees:

- That any damage to buildings, equipment or property owned by the Girl Scouts of the Colonial Coast, other
  than that due to ordinary wear and tear, will be charged to the lessee. The security deposit will be forfeited
  and damages in excess of the security deposit will be assessed to the lessee. Any damage shall be
  reported promptly to the Council.
- 2. To assume full responsibility for injury, damage or loss from any cause whatsoever to the person or properties of others.
- 3. To comply with Girl Scouts of the Colonial Coast's safety policies and procedures. Refer to <u>Volunteer Essentials</u> and <u>Safety Activity Checkpoints</u>.
- 4. To comply with the insurance requirements indicated.
- 5. To comply with use of video/photograph or other media showing the rented property indicated.


## **INSURANCE REQUIREMENTS**

At least 30 days prior to the use of the premises indicated on the confirmation, the lessee agrees to provide a **Certificate of Insurance** to the Council at <u>customercare@gsccc.org</u>.

- 1. The policy must carry a minimum of \$1,000,000 general liability insurance coverage.
- 2. The certificate is to list Girl Scout Council of Colonial Coast as additional insured.
- 3. Special insurance may be purchased for the period of the request. Check with your insurance company.

## **VIDEO/PHOTOGRAPHY RESTRICTIONS**

As an individual, organization or business entering a property rental agreement with Girl Scouts of the Colonial Coast (GSCCC), I/we acknowledge that the GSCCC possesses the absolute and irrevocable right to control and limit, in its sole discretion, the use of any picture, portrait, image, video, photograph or graphic (collectively, a "video or photo"), in all forms, of the property being rented. Accordingly, I/we understand that if I/we wish to use any video or photo which shows the property being rented, (a) copies of the video or photo, together with a written statement of the intended use of the video or photo, must be submitted to, reviewed and approved in writing by the GSCCC Communications and Marketing Department before any such use is permitted, (b) the GSCCC Communications and Marketing Department may withhold or condition its approval of such use in its sole discretion, and (c) any approval, if granted, is expressly limited to the intended use described on the written statement of intended use submitted to the GSCCC Communications and Marketing Department approves. This paragraph, including the right of enforcement, shall survive the expiration or sooner termination of this property rental agreement.

This agreement does not give the lessee the privilege of inviting or including any groups other than the group indicated above. A certificate evidencing the required insurance must be supplied to the Council before the premises may be used by lessee (it must accompany the site agreement) – see insurance requirements above.

Girl Scouts of the Colonial Coast reserves the right to terminate this agreement for the use of its facility by the named lessee, at its discretion, for violation of any of the above rules.
