Additional Details

- Day rental hours are 8am-4pm
- Overnight rental hours are 5pm-12pm the following day.
- Pools are closed Labor Day through Memorial Day.
- A cleaning fee of \$30 will be charged if check-out tasks as outlined in the property package are not completed.
- AEDs is in the Treacle Cabin.
- No charge for GSCCC meetings or training programs.
- Non-Girl Scout renters must sign a **Hold Harmless Agreement** and provide a Certificate of Liability Insurance naming GSCCC as co-insured.
- Written approval is required to bring a personal golf cart. A \$30 fee per golf cart will be charged at the time of reservation.
- Special pricing for non-profit groups may be available. Contact customer@gsccc.org for more information - include the organizations 501c3 document.
- Cancellations made more than 30 days before the reservation start date will receive a refund of the rental fee, excluding the deposit or cancellation fee.
- Cancellations made within 30 days of the reservation start date, as well as no-shows, are **non-refundable**.
