### Nominee Qualifications:

- Girl Scout membership as a youth
- Female entrepreneur or business leader
- Resides in GSCCC's area of southeastern Virginia or northeastern North Carolina
- Distinguished as an outstanding female role model through high levels of achievement in professional activities and volunteer efforts.

**The submitted nomination is the only information used to make a decision. Favorable applications demonstrate a broad variety of accomplishments and wide impact.**

- **Describe the whole person.** Knowing how well she does her job is important, but it is only part of the picture of why your nominee deserves to be honored.
- **Consider whether you want to share the nomination with the nominee at any point.** Many times nominees are touched by what is written about them.
- **Include items that share accomplishments and wonderful things.** Summarizing articles, videos, websites, etc. Feel free to include which publication, website, or news agency featured the article/video/interview, the article title, and a summary of the content.

The selection committee takes into consideration not only the nominees' professional and civic achievements, but also how the nominee exhibits the qualities of the Girl Scout Promise and Law.
